Applicants must meet all the requirements.

**NOTE**

**Please take great care in the preparation of your submissions. Slides and jpegs must be cropped so that only the image portion of the painting is visible. You may have to crop your slide so that this is true. Poor quality includes anything other than the painting image showing i.e. the frame or any other background, images that are off square, out of focus, over or under exposed or with excess glare from sun or flash. Entries of poor quality will be returned without being considered by the jury.**

## THE SIGNATURE STATUS APPLICATION PROCESS

Please read through the entire application package, there are changes to the venue, how you can submit images and which shows are considered to be qualifying.

### Application Checklist

- Ten good slides/digital images and three original works. The three original works **must be** represented in the group of ten images submitted. Extra slides or originals will not be considered.
- An image list showing title, medium, ground, image dimensions (h x w in inches) and price.
- A one-page biography, listing studies and selected exhibitions.
- A non-refundable registration fee of **\$75.00**. Cheques should be payable to the Federation of Canadian Artists or you may pay by credit card.
- A self-addressed envelope, with **sufficient postage**, large enough for the return of your slides or CD.
- The completed application form (page 4).
- The completed Permission/Copyright/Intent to Show Form (page 5).

### Attention Active Members applying for AFCA or SFCA Status:

You must have had eight different works accepted in eight different juried shows in the past four years. All Federation Gallery juried shows qualify as do other FCA shows juried by two SFCA's and one AFCA. Additionally, acceptance into other **major** juried shows, i.e. AWS, *Painting on the Edge*, CSPWC, NWS, NWWS and the B.C. *Images & Objects* show may also count. If you are unsuccessful applying for SFCA Status, you will not by default attain AFCA Status.

**Since 2007: Chapter members, please note only two qualifying shows held in your Chapter may be used per year up to a maximum of six per application. There must be at least two shows which occurred at Federation Gallery in your list. The exceptions to this are the open national shows that are held by Chapters from time to time. They will be considered on par with the Vancouver shows and may be used on your list in lieu of a Vancouver Federation Gallery show.**

### Submission Guidelines

Images can be submitted digitally as jpgs, or by slide.

You may either burn a CD to be included with your other application information or e-mail **digital images**, prepared according to the Juried Show Submissions Guidelines Digital & Slide published on the FCA web site at <http://artists.ca/resources/forms>, in the jpg format only, no tiffs, pdfs or zipped files, to the Gallery Manager at [fcagallery@artists.ca](mailto:fcagallery@artists.ca) and either mail or drop

off the application form, fee and stamped, self-addressed envelope for the return of your results. **All materials must be received on or by February 19, 2010, no exceptions.**

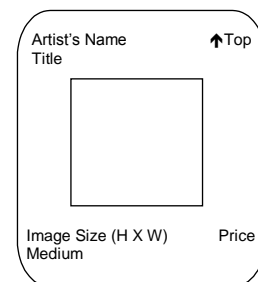
Jpeg files should be named in the following pattern:

**Last name, First name, Title, Size, Medium, Price.jpg**

i.e. Smith, Joe, After the Rain, 12 x 18, acrylic, \$400.jpg

Please note: the use of alpha-numeric strings assigned by the camera or your computer does not identify your work as your own! Images files named DSCN001.jpg or IMG\_002.jpg are not acceptable.

**Slides** must be 35 mm colour, in a 2" x 2" mount. Glass slides are not accepted. No tape or labels except non-protruding silver tape on the film. Indicate name of the artist, title, image size, medium, price and which direction is "up" on the slide mount. Legibly write this information directly on the mount.



### Quality

Please take great care in the preparation of your submissions. Slides and jpegs must be cropped so that only the image portion of the painting is visible. You may have to crop your slide so that this is true. Poor quality includes anything other than the painting image showing i.e. the frame or any other background, images that are off square, out of focus, over or under exposed or with excess glare from sun or flash. Entries of poor quality will be returned without being considered by the jury.

### Jury

Entries are juried by the Federation Board of Governors, which is comprised of SFCA members in good standing. Successful applicants must receive a majority of "yes" votes in order to be accepted.

### Notification

All applicants will be notified by telephone when possible, and in writing, of the Board of Governors' decision. Names of successful applicants will be posted on our website [www.artists.ca](http://www.artists.ca) as soon as possible. Unsuccessful applicants will not receive any input from the jury with the return of their slides. However, a group critique will be held shortly after the jurying which you are welcome to attend to discuss your application with a panel of Senior members.

### Painting Drop-off and Pick-up

Residents of the Lower Mainland must drop off their original works on Thursday, March 11, 2010 at Federation Gallery from 10am - 4pm.

Out of town applicants may ship their works to Federation Gallery from March 2 - March 11, 2010.

Unsuccessful applicants may pick up their original paintings at Federation Gallery starting Tuesday, March 16, 2010. Works to be shipped will be returned as expeditiously as possible.

3. Lapsed AFCA members may rejoin the FCA with automatic Active Status if they pay current dues.
4. Only Associate FCA members may use the letters "AFCA."
5. AFCA members are expected to perform jury duty for the FCA on an as needed basis.
6. Each AFCA member is expected to maintain a consistently high standard of work.
7. AFCA members are eligible to enter the Spilsbury Medal Show.

### **Rights and Responsibilities – SFCA's**

1. Must pay yearly fee.
2. Failure to pay for two years will result in loss of SFCA status.
3. Lapsed SFCA members may join the FCA with automatic Active Status if they pay current dues.
4. Only Senior FCA members may use the letters "SFCA."
5. SFCA members are expected to perform jury duty for the FCA on an as needed basis.
6. Each SFCA member is expected to maintain a consistently high standard of work as an example to the general membership.
7. SFCA members will be asked to participate in the annual Board of Governors' jurying.
8. SFCA members are strongly urged to serve on the Board of Directors if possible.
9. SFCA members are eligible to enter the Spilsbury Medal Show.
10. SFCA members may enter work in any regular Federation juried show without going through the jury process (on a first come first served basis when the space is limited).
